## How Can Planners Meet the Challenges of Climate Change?

#### Abstract:

Effective spatial planning has the potential to:

- Limit and mitigate the effects of climate change through spatial distribution of development, and through approaches to access and design that cap or reduce the emission of greenhouse gases, and
- Identify and support spatial adaptation to enable communities to respond to predicted climate change effects and, more critically, to improve capacity to respond to uncertainty.

Janet is a chartered town planning consultant with her own practice based in York, U.K. She has 10 years local government experience in Cardiff, Edinburgh and South Yorkshire, and has been in working in the private sector for 25 years.
